Finally, I consent and authorize the board, through its membership committee or otherwise, to invite and receive information and comment about me from any member or other person, and I agree that any information and comment furnished to the board by any member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

**\*\*\*SOUTH GEORGIA MLS DATABASE AGREEMENT\*\*\***

This agreement, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, between South Georgia MLS, a Georgia corporation hereinafter referred to as "MLS," and \_\_\_\_\_, hereinafter referred to as "Salesperson," whose license is placed with \_\_\_\_\_, Principal/Broker/Appraiser/Owner, \_\_\_\_\_ (Firm).

Witnesseth:

It is understood between the parties hereto that said assigned database password and lock box password are of vital importance to the security of the Multiple Listing Service and should said password/s come into the possession of any other person, irreparable damage to the MLS will result. Therefore, Salesperson covenants and agrees that (1) they will take all reasonable care to protect said password from being known; that (2) they will not permit said password to be used by any other person; that (3) they will immediately report to the MLS any attempt by anyone to utilize password; that (4) in the event Salesperson's license becomes inactive, suspended, or revoked for any reason, Salesperson shall immediately notify MLS.

A fine of up to \$5,000.00 shall be imposed on Salesperson for misuse of said database password or lock box. The term "Salesperson" shall mean the person receiving a lock box account and/or database password from MLS and shall include the terms "Appraiser," "Salesman," "Saleswoman," "Associate Broker," and "Broker." Should Salesperson either for himself or in conjunction with other person willfully permit said password or lock box account to be used by any other person during the term of this agreement, same shall be deemed a violation of this agreement and Salesperson shall be liable to MLS for all expenses necessary to re-establish its lock box and/or database security, as well as any other loss or damage that might result to MLS there from. Also note that No one shall be required to lease a lock box account except on a voluntary basis.

IN WITNESS WHEREOF, MLS has caused this agreement to be executed by its appropriate office, or designated agents, and Salesperson has executed this agreement this agreement this day and year first above written.

I hereby apply for Principal membership in the South Georgia MLS (MLS) and agree to a one-time non-refundable initial participation fee of Two Thousand dollars (\$2,000), an application fee of \$150.00 plus quarterly fees which I understand will be returned to me in the event I am not accepted to membership. I agree as a condition of membership in the MLS to abide by all relevant rules and regulations and other obligations of participation, including payment of dues. I will on my own initiative thoroughly familiarize myself with the South Georgia MLS Bylaws and Rules and Regulations. I further agree that my act of paying dues shall evidence my initial continuing commitment to abide by the aforementioned *Rules and Regulations* as from time to time amended.

*I further agree to be bound by the MLS Standards of Conduct, and if a REALTOR® Member, with the NAR Code of Ethics as established in the NAR Code of Ethics and Arbitration Manual, including the obligation to submit to ethics hearings and the duty to arbitrate contractual disputes with other REALTORS® in accordance with the established procedures of the board. I understand that a violation of the Code of Ethics, if applicable, or MLS Rules and Regulations may result in suspension or termination of MLS rights and privileges and that I may be assessed an administrative processing fee not to exceed \$500 which may in addition to any discipline, including fines, that may be imposed.*

I acknowledge and agree that within 180 days from the date this application is approved, that I will attend offered MLS Rules and Regulations training and MLS computer software training, without a written excused absence from the South Georgia MLS, that my membership will be suspended until the requirement is met.
